



OTHER FAMILY CHECKLIST

(SUBCLASSES 114-Aged Dependent Relative, 115-Last Remaining Relative AND 116-Carer)

The following documentation is required for a full assessment of your application. Lodgement of a complete application will facilitate the processing times in the majority of cases. Your application could be delayed if outstanding documentation is requested AFTER lodgement.

All application and sponsorship forms are available free of charge from www.immi.gov.au

All visa applicants will require an interview.

Please contact VFS Pty Ltd (VFS) for their acceptable payment types and current immigration visa application charge amounts. VFS will charge a service fee above the visa application charge.

Please **do not** submit the actual passport if the health examination has not been completed as the passport will be required for the health examination.

You MUST return this document when you submit your application and pay the required fee.

You are requested to provide the following items as relevant to your application. Please note that documents not in English must be translated into English and the original translation must be submitted. A true certified copy of the original is also required.

- Completed and signed application Form 47OF (available from www.immi.gov.au)
- Completed and signed sponsorship Form 40 (available from www.immi.gov.au)
- A copy/printout of bank transfer receipt showing payment of visa application fee. Current fees can be found at www.vfs-au.co.za
- A photocopy of the biodata page of the current valid passport of each passport holder is required for VFS purposes.
- Passport photos for the applicant.
- Certified copy of passport for all persons migrating. Please **do not** submit the actual passport if the health examination has not been completed as the passport will be required for the health examination.
- Certified evidence of any name changes – i.e. by deed poll / marriage etc for all persons included in the application
- Certified copy of military service record or discharge certificate
- Certified copy of FULL birth certificate showing both parents names (obtained from the Department of Home Affairs or equivalent) for ALL persons applying for migration and any child/children under the age of 18 not migrating
- Certified copy of your marriage certificate.
- Certified copy of any divorce certificates of previous partner/s of applicant and sponsor
- Certified copy of any death certificate of previous partner/s of applicant and sponsor
- Proof of Sponsors relationship (Birth Certificates, Marriage certificates, Australian Citizenship etc. - all documents must be ORIGINALS or certified copies.)
- Aged Dependent Relative – Evidence that you are wholly and substantially dependent on your Australian relative for financial support for basic needs of food, clothing and shelter or because you have a disability which prevents you from working, and that the support has been provided for a reasonable period (usually 3 years). If you are claiming dependency, documented

evidence of the transfer of funds on a regular basis over a reasonable period will need to be provided to support your claim.

- Carer visa - Health Services Australia (HAS) certificate
- Police clearance certificates for all persons who are 16 years and older from all countries in which they have lived for a period of 12 months or more in the past 10 years. This includes any non-migrating children less than 18 years of age. If the sponsor is an eligible New Zealand citizen they are required to provide police clearance certificates for all countries in which they have lived for a period of 12 months or more in the past 10 years. **ORIGINALS** must be provided, as copies of police clearances, even when certified, are not acceptable for migration purposes.
- Health examinations are required for all persons included in the application and any other children (under the age of 18) who are not migrating. Radiological (chest) examinations are required for persons who are 11 years and older. If the sponsor is an eligible New Zealand citizen they are required to undertake full health examination (Forms are available from panel doctors and panel radiologists and a list of panel doctors are enclosed).
